- b. Permanently irrigated non-sod, mulch beds, etc. at **\$5.58** per square foot of irrigated area.
- c. Native grass seed which is temporarily irrigated for two growing seasons with the irrigation system removed at the end of the second season at **\$0.00** per square foot.

The City collects tap fees based on the fee schedule in place at the time payment is made.
